The Grantee shall indemnify and hold Women-n-Charge harmless, including its elected and appointed Board members from and against all claims, damages, losses, and expenses, including, but not limited to, attorney's fees and costs, and attorney's fees on appeal arising out of or resulting from the carrying out of this Agreement.

Past Grant winners are asked to wait at least 2 years before applying for an additional Grant.
